### 20/19 Declarations of Interest:

There were no Declarations of Interest in respect of any matters on the agenda.

#### **20/20 Minutes:**

The minutes of the meeting held on 6th January 2020, having been circulated were accepted as a true record and signed by the Chairman.

# 20/21 Casual Vacancy:

There had been no expressions of interest in the Casual Vacancy in the Witherslack Ward of the parish. The Clerk explained that, because of the coronavirus pandemic, the Parish Elections had been postponed until May 2021, when there will be an Election for the whole of this parish.

## 20/23 Proposed removal of telephone kiosks:

It was reported that the kiosk at Millside is being used for book distribution. The Clerk will make enquiries with BT to confirm the adoption of these kiosks by the Council.

## 20/24 Parish defibrillator:

Councillor Douglas reported that a meeting is due to be held and the management plan will be with Community Heartbeat Trust.

# 20/25 Speed limits in the village:

Councillor Douglas is in touch with CCC Highways, and alternatives have been suggested such as traffic calming, which would be expensive. It was suggested that an open meeting is arranged, when this is possible, with interested parties.

A letter had been received from a resident of Meathop, asking for help with the problem of speeding vehicles there, and this had been added to the issues already under discussion.
